- ▶ Adjacent lots and dwellings
- ▶ Distance from hives to any dwellings on adjacent lots (Minimum of 30')

Issuance of the Permit shall in no way relieve the applicant/owner of his/her responsibility of complying with applicable zoning and state regulations. This permit will expire December 31st of the year of issue.
